MOTION NO. 25-374

APPROVING ADMINISTRATIVE MATTERS PRESENTED AT
GENERAL LEGISLATIVE SESSION ON AUGUST 13, 2025

WHEREAS, the Snohomish County Charter requires the Snohomish County Council to consider and approve certain proposed actions that are of a routine, recurring and non-controversial nature; and

WHEREAS, the Council finds that review and approval of such routine, recurring and non-controversial matters together in a single written motion is an efficient way to process such items and maintains effective oversight of administrative operations; and

WHEREAS, the following action items were presented at a General Legislative Session where such matters are routinely considered;

NOW, THEREFORE, ON MOTION, the Snohomish County Council hereby approves the following action items:

- 1) Piggyback Award Recommendation for the use of a “piggyback” or “cooperative purchase” under SCC 3.04.220 utilizing a competitive bid process approved by the Office of Washington State Department of Enterprise Services to authorize contract usage for the County purchase of cell phones, accessories and associated voice and data services from two awarded categories - Cellular Wireless Services and Equipment and Accessories ([ECAF 2025-2369](#))
- 2) Piggyback Award Recommendation for the use of a “piggyback” or “cooperative purchase” under SCC 3.04.220 utilizing a competitive bid process approved by the Office of Washington State Department of Enterprise Services to authorize contract usage for the County purchase of uniforms, related customization and accessories ([ECAF 2025-2370](#))
- 3) Bid Award Recommendation PW-25-0453SB SWRTS Scale Replacement, Allied Construction Associates in the amount of \$797,600.00 plus applicable Washington State Sales Tax ([ECAF 2025-2585](#))
- 4) Piggyback Award Recommendation for Facilities and Fleet’s use of a “piggyback” or “cooperative purchase” under SCC 3.04.220 utilizing a competitive bid process approved and awarded by Sourcewell for the purchase of heavy construction equipment, related attachments and technology and in accordance with the Council Approved agreement between Sourcewell and Snohomish County under Motion 18-247 with an estimated spend of \$4,000,000 over four (4) years ([ECAF 2025-2586](#))
