AMENDMENT 4 TO HUMAN RESOURCES RECRUITMENT AND SELECTION AGREEMENT TO EXTEND THE AGREEMENT FOR THREE YEARS

This Amendment 4 to the "Master Agreement for Recruitment and Selection Software," (the "Master Agreement"), executed on September 28, 2011, and amended on August 27, 2014, December 10, 2020, and June 22, 2021, by and between Snohomish County, a political subdivision of the State of Washington (the "County") and GovernmentJobs.com, Inc., dba NeoGov, duly registered and authorized to conduct business in Washington State (the "Contractor") is made and entered into on this 16th day of Sept., 2021.

- WHEREAS, to that end, the parties have agreed to extend the Master Agreement for three years through September 27, 2024 for an additional sum of One Hundred One Thousand Six Hundred Sixty-One Dollars (\$101,661.00) plus applicable sales tax.
- **NOW, THEREFORE,** for and consideration of the mutual benefits conferred on both parties, the parties agree as follows:
- **Section 1.** Exhibit A-1, Order Form for services from 9/28/2021 through 9/27/2024 is added to the Master Agreement.
- **Section 2.** All other terms of the Master Agreement, as amended by Amendment 1, Amendment 2, and Amendment 3, shall remain in full force and effect, except as expressly modified by this Amendment 4.
