a. Ordinance 23-076, approving and authorizing the Snohomish County Executive to sign the Interlocal Agreement between Snohomish County and the Stillaguamish Tribe of Indians for Wood Acquisition to Support Jim Creek Restoration Project

Ryan Countryman, Sr. Legislative Analyst, provided a staff report. He said this is a grant funded project that Council has previously approved and he explained additional details of the project. He said the total cost of the project is \$30,600.00 and will have no impact to the General Fund.

ACTION: Councilmember Dunn made a motion to set time and date for a public hearing for Ordinance 23-076, for Wednesday, August 23, 2023, at the hour of 10:30 a.m. Acting Chair Low seconded the motion and it carried unanimously.

 b. Motion 23-307, approving an Aquatic Lands Lease renewal between the State of Washington and Snohomish County at Kayak Point Park

Ryan Countryman, Sr. Legislative Analyst, provided a staff report and explained this is an aquatics land lease for a period of 30 years. He provided background information and stated there is no cost to the County associated with this lease.

ACTION: Councilmember Dunn made a motion to approve Motion 23-307. Councilmember Peterson seconded the motion and it carried unanimously.

Ryan Countryman, Sr. Legislative Analyst, provided a staff report and explained the County will be decommissioning Skype for messaging and voicemail and moving to Teams. He said the agreement is for one year and the cost of services will be \$173,704.80.

Ryan Countryman, Sr. Legislative Analyst, provided a staff report. He explained Minotaur Mazes is an interactive educational exhibit at the Evergreen State Fair, that is expected to be a popular new attraction. The total cost of services is \$40,500.00.

ACTION: Councilmember Dunn made a motion to approve Motion 23-331. Councilmember Peterson seconded the motion and it carried unanimously by the three members present.
