Summary: District Court is receiving unanticipated grant funds from the Administrative Office of the Courts. The ordinance makes a supplemental appropriation in the 2023 Budget in the amount of \$162,648.67, to provide expenditure authority to fund staffing and other services for District Court's Mental Health Court. Grant funding will allow the Mental Health Program Coordinator to increase from 0.5 to 1.0 FTE, the Legal Process Assistant II to increase from 0.5 to 1.0 FTE, fund and hire a 1.0 FTE Therapeutic Court Case Manager, and fund additional equipment, supplies, and transportation.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.
