**Subject:** Authorizing the Executive to sign the agreement for scanning, image

enhancement, and indexing services between Snohomish County and US

Imaging, Inc.

**Scope:** RFP 23-006BC was issued to fill the Auditor's need for scanning, image

enhancement, and indexing services in order to import the County's historical images from the 1860s to 1976 into the County's recording system. US Imaging, Inc was selected, and will ensure digital images of all pages of County records from 1760 through 1976 are legible and readable (when reproduced as required by RCW 64.04.015) and prepared for import to Landmark Recording System. US Imaging, Inc. will inspect and report the quality of existing digital images (provided by the County) and provide the County with recommendations for either manual enhancement of existing image or creation of new image. Enhancements may include manual crop, manual area enhancement, reverse dual polarity, reverse marginal notations, or masking. Amount of the contract is \$1,000,000 annually, not to exceed \$3,500,000 in total.

This contract is to scan, enhance, index, and import all county recorded documents from the 1860s to 1976, thereby allowing residents, costumers, and researchers the ability to search for these records online, which has not been possible to date.
