APPROVING AND AUTHORIZING THE COUNTY EXECUTIVE TO SIGN AN INTERLOCAL AGREEMENT BETWEEN SNOHOMISH COUNTY AND EDMONDS SCHOOL DISTRICT NO. 15 FOR BEHAVIORAL HEALTH FACILITY

WHEREAS, Snohomish County received Coronavirus Local Fiscal Recovery (CLFR) grant funds pursuant to the American Rescue Plan Act, PL 117-2; and

WHEREAS, the Department of Human Services issued a Notice of Funding Availability for Behavioral Health Facilities Capital Projects in November 2022; and

WHEREAS, the Edmonds School District No. 15 applied for these funds, and its project was selected by the County; and

WHEREAS, Chapter 39.34 RCW, the Interlocal Cooperation Act, authorizes public agencies, including the County and Edmonds School District No. 15, to enter into cooperative agreements with one another to make the most efficient use of their respective resources; and

NOW, THEREFORE, BE IT ORDAINED:

Section 1. The Snohomish County Council approves the Interlocal Agreement Between Snohomish County and Edmonds School District No. 15 for Behavioral Health Facility (HCS-24-AR-2101-290) for \$1,315,269.00.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.
