Description of Work

Provide all design services necessary to complete final plans, special provision preparation and estimates (PS&E) and provide Construction Phase services for Snohomish River Bridge #1 that carries Airport Way/Avenue D over the Snohomish River south of the city of Snohomish.

The Local Agency of Snohomish County desires to supplement the Agreement entered into with **TranTech Engineering**, **LLC** and executed on December 16, 2022 and identified as Agreement No. CCF03-22, as amended by Supplement No. 1 on September 14, 2023. All provisions in the basic agreement remain in effect except as expressly modified by this supplement.

WHEREAS, David Evans and Associates, Inc., a State of Oregon corporation registered to do business in the State of Washington, UBI# 600 227 608, has acquired certain assets of TranTech Engineering, LLC as of the effective date of September 28, 2024, including this Agreement, and

WHEREAS, the County has formally consented to the assignment of the Agreement to David Evans and Associates, Inc. as evidenced by the Assignment document attached hereto and by this reference made part of this supplement, and

The changes to the Agreement are described as follows:

#### Introduction

Under the Snohomish River Bridge #1 Scour Mitigation Project, Snohomish County (AGENCY) has requested that David Evans and Associates, Inc. team (CONSULTANT) prepare a supplement that provides justification for additional professional services exceeding original Scope of Services, Agreement No. CCF03-22.

Additional design phase services are required by the CONSULTANT'S Design Team under Work Elements 6, 7 and 9.1 (30% Design), to further explore cost-saving alternatives that can be feasibly advanced into Work Element 9.2 (60% Design). These additional services include:

- Consideration of a new outrigger system with a link (new cap) beam that frames into the existing and new columns hence providing additional "framing actions" to resist the elevated forces due to a potential scour-induced loss of support; and
- Methods of construction for such outrigger system with the possibility of avoiding the costly work bridges (two construction trestles were estimated at \$2.4M) by implementing methods like:
  - Jack-up and Flexifloat barges,
  - o Driving matrices of smaller diameter piles

#### Additional design phase scope of services

In July 2023, the CONSULTANT'S Design Team developed, initially, ten mitigation alternatives that were vetted and refined by the AGENCY and the CONSULTANT during a series of meetings culminating in selection of the top three most favorable alternatives by August of 2023. These recommended alternatives relied on providing new drilled shafts that penetrated to depths below scour depth with strengthened cap beams to resist reactions imposed by the bridge superstructure during design scour events. The Team had to consider the availability of up to date (or lack thereof) geotechnical site-specific test data with their recommended selection as per project schedule, the design is to proceed to the 60% phase by which time structural member sizes are expected to be final.

The CONSULTANT'S Design Team also considered scour and stream stability countermeasures such as articulated concrete blocks, Gabion mattresses, and rock riprap; yet they were deemed inefficient because they did not address the issue of lack of sufficient embedment of the existing shafts, in addition to the perceived difficulties with their installation, maintenance and permitting processes.

These challenges resulted in mitigation recommendations that were costly. Therefore, additional investigations and design is to be conducted by the CONSULTANT, to explore cost-saving alternatives that can feasibly be advanced into Work Element 9.2:

Work Element 1: Project Management (Supplemented)

Work Element 6: Hydrology (Supplemented)

Work Element 7: Constructability Review, Construction Schedule, And Estimation Supplemented)

Work Element 9.1: 30% Design (Supplemented)

The extra services are identified in the detailed Scope of Work below:

#### SCOPE OF WORK DEFINED

#### **Work Element 1: Project Management (Supplemented)**

This task includes project administration, meeting coordination, and design team management.

- CONSULTANT team meetings approximately four (4) additional team meetings are assumed for the additional design services,
- CONSULTANT's Design Team management below is a list of continued tasks to be provided for the duration of the additional design,
  - o Schedule and coordinate with CONSULTANT'S Design Team,
  - o Monitor project budget.
  - o Maintain regular informal contact telephone discussions and electronic mail.

#### **Deliverables:**

o Invoices and progress reports.

#### **Work Element 6: Hydrology (Supplemented)**

The additional services provided under this Work Element include the following:

o Additional mitigation alternatives to be evaluated that are beyond what was originally envisioned.

#### Work Element 7 – Constructability Review, Construction Schedule, And Estimation (Supplemented)

The additional services provided under this Work Element include exploring cost-saving construction methods per following:

- o Jack-up barges for installation of the rehabilitation shafts in a tidally influenced river
- o Driving matrices of smaller diameter piles utilizing conventional barges
- Combined site visit with the Agency at the 60% and 90% design levels

#### **Work Element 9.1 – 30% Design (Supplemented)**

The additional services provided under this Work Element are per following:

- <u>Preliminary Structural Design:</u> The CONSULTANT to review the structural viability of the cost saving measures mentioned above that were not originally envisioned. The effort include a comprehensive search of both conventional and novel methods with potential to address the deficiencies in load bearing capacity of bridge piers in event of a scouring flood from the perspectives of engineering and economy. Two-dimensional preliminary models of Pier No. 3 with expected forces are to be investigated, with coordination with geotechnical subconsultant on sufficiency of the new shaft sizes for bearing capacities and required right-of-way for the widened pier caps. Extensive discussions and work sessions are and will be undertaken with a focus on constructability issues.
- New Link/Cap Beam Concept: Due to the shaft construction clearances, the lengthening of the cap beam to support
  the outrigger shafts becomes challenging. The CONSULTANT must come up with a new link beam concept located
  below the existing cap that is viable and meets the hydrology, constructability and structural requirements.

Originally a standard cap extension at the existing cap location was envisioned to be strengthened by customary methods like fiber-reinforced polymer jacketing or post-tensioning. The increased internal forces due to a demand for longer cap span and the weight of the unsupported existing shafts during the scour event made these strengthening schemes less favorable for advancement to the 60% design level.

• Estimate: Cost estimates for all the cost saving measures mentioned above are developed by the CONSULTANT. Updated unit cost is developed to reflect current bidding climate.

## Exhibit B DBE Participation Plan

This consultant agreement has a mandatory DBE goal of 19%. Consultant will be required to report DBE information monthly at <a href="https://wsdot.diversitycompliance.com/">https://wsdot.diversitycompliance.com/</a>.

The original agreement was with this TranTech Engineers, LLC a certified DBE consultant, #D2W0025137, and this consultant has since been acquired by David Evans and Associates, effective September 30, 2024, which is not a DBE firm.

As of this supplement, the total contract amount is \$1,003,437.15. To date, the DBE prime, TranTech, has completed \$368,381 worth of work; DBE subconsultants HWA GeoSciences, Inc, \$51,452, and Ott-Sakai, \$30,088, respectively. This is equivalent to 44.84% of the total contract amount.

David Evans and Associates will continue utilization of the contracted subconsultants for remaining available work on the agreement.
