<u>Authority Granted:</u> Approve and authorize the County Executive to sign Task Order #1 of the Project Administration Agreement between Snohomish County and Sound Transit for the Everett Link Extension and OMF North Project in the amount of \$702,527, and further authorizes the director of Public Works or designee to approve amendments up to \$70,252, provided that sufficient authority exists, for a total amount not to exceed \$772,779, under SCC 3.04.140(1) and 3.04.210.

Background: Sound Transit 3 Regional Transit System Plan was approved and funded by voters in November 2016 which included the Everett Link Extension project. In August 2023, Snohomish County, the cities of Everett and Lynnwood and Community Transit entered into a Partnering Agreement for the Advancement of the EVLE project. Snohomish County and Community Transit have negotiated a Master Agreement, Motion 24-038.
