APPROVING THE 2026 COUNTY OFFICE SPACE PLAN

WHEREAS, County Council approved amendments to Snohomish County Code 4.46 on October 20, 2008 directing the Department of Facilities & Fleet ("Department") to prepare and submit to the County Council a proposed office space plan on or before December 31 of each year for the following fiscal year or biennium; and

WHEREAS, the Department of Facilities & Fleet submitted the 2026 County Office Space Plan report on or before December 31, 2025; and

WHEREAS, the County Council discussed and reviewed the 2026 County office space plan report with the Department of Facilities & Fleet including Exhibit A which listed the Department's recommended changes to the 2026 County office space plan including estimated cost, implementation plan/timetable and fund source availability, if any, for each change.

NOW, THEREFORE, ON MOTION, the Snohomish County Council approves the 2026 County Office Space Plan as submitted by the Department of Facilities & Fleet, including the authorization of the Department's recommended changes.
