

AMENDMENT NO. 1 TO THE AGREEMENT FOR
CONTRACT MEDICAL STAFFING WITH HEALTH PROS NORTHWEST

This Amendment No. 1 To The Agreement for Contract Medical Staffing (“Amendment No. 1”), is entered into by and between Snohomish County, a political subdivision of the State of Washington (the “County”), and Health Pros Northwest, a Washington Professional Limited Liability Company (“Health Pros Northwest” or the “Contractor”).

WHEREAS, on February 18, 2021, the County and the Contractor entered into an Agreement for Contract Medical Staffing (“Agreement”). The Agreement governs the terms by which the Contractor provides temporary healthcare personnel; and

WHEREAS, the parties wish to revise the Agreement’s fee structure.

NOW THEREFORE, in consideration of covenants, conditions, performances, and promises hereinafter contained, the parties mutually agree to amend the Agreement for Contract Medical Services as follows:

1. Exhibit A of the Agreement, shall be removed and replaced with a new Exhibit A, included with this Amendment No. 1, and hereby incorporated by reference.
2. Except as expressly provided in this Amendment No. 1, all of the terms and conditions of the Agreement are ratified and affirmed and remain in full force and effect.
3. This Amendment No. 1 may be executed in counterparts, each of which shall constitute an original and all of which shall constitute one and the same agreement.

Overtime: shall be 1 ½ (One and one half) times the listed rate and shall be charged for time in excess of forty (40) hours per week when all forty (40) hours upon which the overtime is based were worked at CLIENT location.

Overtime and Holiday Rates may NOT be combined for additional payment. Time and a half is the highest rate that CLIENT will pay under the terms of this Agreement.

Travel: For any AGENCY Personnel requiring an overnight's stay, a fee of \$200 will be billed for each night stay needed. If housing is provided by CLIENT, no travel will be billed.
