When a city has imposed a tax under RCW 84.14.530(1)(b) prior to the county's imposition of SCC 4.126.010, there shall be allowed against the tax imposed by SCC 4.126.010 a credit for the full amount of any sales or use tax imposed by a city under RCW 84.14.530(1)(b) upon the same laxable event.

Section 2. Implementation, County offices and agencies shall take all necessary steps to implement this ordinance as soon as possible in accordance with RCW 82.14.055. The clerk of the council shall forthwith transmit a certified copy of this ordinance to the department of revenue of the State of Washington.

Section 3. Plan Crestion and Approval. The executive's office shall coordinate with council, cities and countity partners on the creation of a final business expenditure plan. Prior to the expenditure of any receipts of the sales and use tax, the plan must be presented to council for consideration of approval by motion.
