On April 3<sup>rd</sup>, 2002, the County Council adopted Amended Ordinance No. 02-007, Adopting a New Snohomish County Code Title 33, Relating to the Protection and Preservation of Snohomish County Archaeological and Historic Resources, Sites and Districts. Within this document, Chapter 33.05 states the purpose of having an historic commission, membership requirements and the process for appointment, powers and duties of the commission, and functional details relating to the commission's operation.

The historic preservation commission will have nine members with at least one from each Council District. In choosing these candidates I have taken into consideration the membership criteria in Chapter 33.05.020. The same section states that, "The original appointment of members to the commission shall be as follows: three for two years, three for three years, and three for four years." The terms proposed for each candidate in the attached background information matrix satisfy this requirement.

The recruitment process included notice of the initial and extended deadlines for application in all local newspapers as well as in the Planning and Development Department's *Heritage Perspective* newsletter. The deadline for applications was extended twice: from June 15<sup>th</sup> to June 30<sup>th</sup>, and from June 30<sup>th</sup> to July 15<sup>th</sup> in order to fill the nine positions available. Nine applications were received and all are included in this recommendation.

I am convinced that the recommended slate of candidates has the skills, desire and ability to contribute positively to the important work of the new commission. Pursuant to SCC 2.03.040(1), I recommend these appointments to the terms proposed in the attached background information matrix. Thank you for your consideration.
