

Standing committees are advisory bodies and cannot take final council action within the meaning of RCW 42.30.020(3). Any council member may attend and participate in meetings of standing committees so long as written notice of a special council members when council action is taken within the meaning of RCW 42.30.020(3) and written notice of the meeting is required by SCC 2.48.030.</li> <li>(2) Meetings of standing committees shall be subject to the requirements of SCC 2.48.030 through 2.48.070, to the event applicable, provided that any regular meeting may be cancelled by the committee may call a special meeting. Regular meetings of standing committees shall be held twice monthly in the Henry M. Jackson Board Room, Robert J. Drewel Building, eighth floor, 3000 Rockefeller Avenue, Everett, Washington, at the times stated in subsection (3) of this section, except that if any regular meeting falls on a holiday such regular meeting shall be held on the next business day unless cancelled by the committee chairperson or a majority of the committee chairperson or a majority of the committee may call a special meeting.
