Snohomish County Code Section 2.48.170, last amended by Amended Ordinance 21-041 on August 18, 2021, is amended to read: 12 13 14 (1) The chairperson shall appoint the members of council standing committees, and for each committee shall designate a committee chairperson. Standing committees 15 are advisory bodies and cannot take final council action within the meaning of 16 17 RCW 42.30.020(3). Any council member may attend and participate in meetings of 18 standing committees so long as written notice of a special council meeting is given for any special committee meeting attended by three or more council members when 19 20 council action is taken within the meaning of RCW 42.30.020(3) and written notice of 21 the meeting is required by SCC 2.48.030. 22 (2) Meetings of standing committees shall be subject to the requirements of 23 SCC 2.48.030 through 2.48.070, to the extent applicable, provided that any regular 24 meeting may be cancelled by the committee chairperson and the committee 25 chairperson or a majority of the committee may call a special meeting. Regular 26 meetings of standing committees shall be held twice monthly in the Henry M. Jackson Board Room, Robert J. Drewel Building, eighth floor, 3000 Rockefeller Avenue, Everett, 27 28 Washington, at the times stated in subsection (3) of this section, except that if any 29 regular meeting falls on a holiday such regular meeting shall be held on the next business day unless cancelled by the committee chairperson or a majority of the 30 31 committee. 32 (3) The following standing committees and regular meeting times are 33 established: 34 (a) Finance and economic development – ((second and fourth Tuesday at 35 10:30 a.m.)) first and third Monday at 1:30 p.m.; (b) Law and justice/human services – ((second and fourth Monday at 1:30 36 p.m.)) second and fourth Monday at 1:30 p.m.; 37 38 (c) Conservation, sustainability and recreation – ((second and fourth 39 Tuesday at 9:00 a.m.)) second and fourth Monday at 11:00 a.m.; 40 (d) Planning and community development – ((first and third Tuesday at 41 10:30 a.m.)) second and fourth Monday at 2:30 p.m.; (e) Public works and infrastructure – ((first and third Tuesday at 9:00 42 43 a.m.)) first and third Monday at 11:00 a.m. 44 (4) Any recommendation of a council standing committee shall be reduced to 45 writing and signed by the committee chairperson. Written majority or minority reports

BACKGROUND: Currently, Standing Committees are split between alternating weeks on Monday's and Tuesdays. The proposed ordinance would move all standing committees to Monday's, but maintain the alternating weeks. If approved: *first and third Monday* - Public Works at 11:00 a.m. and Finance at 1:30 p.m. and second and fourth Monday - Conservation, Sustainability, and Recreation at 11:00 a.m., Law and Justice/Human Services at 1:30 p.m., and Planning at Community Development at 2:30 p.m. Additionally, the intent would be to move the Administrative Session start time from 10:30 a.m. to 10:00 a.m. on Monday's. The time for Administrative Session is not codified and therefore no amendment is needed to make this change.
