I am trained in ToP (Technology of Participation) Facilitation, a tool designed by the US Institute of Cultural Affairs to “harness peoples’ energy and wisdom to build group consensus and implement programs and projects.” Additionally, I served for over 3 years as special education coordinator at the Arc of Snohomish County, where I was responsible for designing and delivering programming to empower parents/families in navigating special education systems including presenting at the state, county and school district level on IEP Parent Partner programs and the Charting the LifeCourse framework.

As a parent whose child’s disabilities have been present since birth, I was shepherded quickly into the role of advocate, learning quickly that my expectations for my son AND THE COMMUNITY around him, were paramount in his and others’ success. This advocacy role has continued throughout his school career (he is 19 now), including being a founding member and past chairperson of the Edmonds School District Special Education PTSA committee (now ESD SEPAC), thus participated in numerous steering committees regarding policy and community engagement, as well as district hiring committees for Superintendent, HS Principals, Executive Director for Teaching & Learning, Executive Director for Student Services (Sped Ed), and so on. I also volunteer as a costume designer/seamstress for my son’s school and community theater activities, and take every opportunity to share the benefits of inclusion.
