(2) The chief of staff shall coordinate work and the providing of information among council members, coordinate action and the providing of information between the councy executive and the council, work with the chairperson and clerk of the council on the calendar and agendas, supervise and act as the employing official for the clerk of the council and staff and perform such other duties as are delegated by the council through the chairperson. In exercising responsibilities as the employing official, the chief of staff shall consult with the council before finalizing any offer or termination of employment. The chief of staff shall serve at the pleasure of a majority of the council, and shall be exempt from the council shall be its clerk, attend meetings and hearings of the council as directed by the chief of staff, cause minutes of meetings and hearings of the council as directed by the cief of staff, supervise routine management of council affairs subject to the supervision of the chief of staff, and perform such other duties as are delegated by the clerk of the council affairs subject to the supervision of the chief of staff, and perform such other duties as are delegated by the chief of staff. (4) The assistant clerk shall carry out the duties of the clerk of the council in the clerk's absence, and perform such duties as are delegated by the clerk of the council.
