Pursuant to the above referenced Agreement and Amendments No. 1-2, County hereby extends and amends the agreement for the 2021 Evergreen State Fair, Monroe WA.

Due to the Covid-19 pandemic in 2020, the 2020 Fair had to be canceled; which canceled the contract with Butler Amusements Inc. for 2020, the last year of their contract.

County and Contractor agree to these terms for modified carnival operations for a modified 2021 Fair:

List of exact rides (including layout map), height restrictions, ticket prices, games, food, and novelties must be submitted to the Fair by July 15, 2021.

No minimum quantity of amusement rides and shows for this modified fair.

Fair Staff will work with Carnival on the detailed operational plan for health and safety protocols and all other carnival operations.

Insurance and Worker's Comp Coverage:

Updated documents must be in place by July 15, 2021.

2021 Financial Offer to the Fair:

45% of advance sale ride gross

45% of ride gross up to \$250,000;

40% of the next \$500,000 and

35% over \$600,000

20% of Super Spectacular Ride Gross for up to 3 rides

\$1,500 per Novelty (no minimum)

\$1,000 per each game concession (no minimum)

\$1,300 per each food concession (no minimum)

No minimum guarantee amount

No capital improvement investment for 2021

All other terms and conditions of the contract shall remain unchanged.
