**BACKGROUND:** The proposed code amendments revise the current language to include the timing of container placement (no sooner than the day prior to collection) and the collection timing of containers (within 12 hours of collection) and include the placement of containers (no farther than ten feet from the traveled way), so as not to interfere with vehicular pathways, driveways, parking, pedestrian walkways, trails, bicycle lanes and rights-of-way maintenance. A summary of the proposed ordinance is as follows:

#### PROPOSED ORDINANCE NO. 22-041

RELATING TO THE RESIDENTIAL COLLECTION OF SOLID WASTE AND RECYCLABLES IN UNINCORPORATED AREAS OF THE COUNTY; AMENDING CHAPTER 7.42 SCC

<u>Section 1.</u> Snohomish County Code section 7.42.020, last amended by Ordinance No. 98-002 on February 11, 1998, is amended to add subsection (9) to read as follows:

- (9) "Collection container" means a container typically used for recycling, yard debris or garbage, with the term used interchangeably with solid waste bin, garbage container, recycling container, recycling carts, mini-can, one-can, two-can, three-can, yard debris container, or yard waste collection cart;
- <u>Section 2.</u> Snohomish County Code section 7.42.040, last amended by Ordinance No. 98-002 on February 11, 1998, is amended make housekeeping corrections as follows in the following subsections:
  - (4)(a) Solid waste collection companies shall offer bulky materials collection service, for reuse, recycling, or disposal, both inside and outside the recycling service zone. Solid waste collection companies are encouraged to develop innovative and <u>cost-effective</u> routing and services which periodically provide for bulky materials collection throughout their service area.
  - (5)(b) Recycling and yard debris collection containers made of plastic shall be manufactured using a percentage of post-consumer recycled materials, if available and competitively priced.

Section 3. A new section is added to chapter 7.42 of the Snohomish County Code to read:

#### 7.42.045 Set out of containers.

No collection container shall be kept or stored within the confines of any public right-of-way in a residential area (urban/suburban or rural). Collection containers shall be kept on private property in a convenient and accessible location preferably near the residence without interfering with the reasonable enjoyment of such private property or adjoining property. No sooner than the day prior that solid waste is normally collected, collection containers should be placed in a readily accessible location not farther than 10 feet from the traveled roadway, but not interfering with pedestrian or bicycle traffic. Collection containers should be removed promptly (within 12 hours from collection) from all traveled ways (including but not limited to vehicular pathways, driveways, parking, pedestrian walkways, trails, and bicycle lanes) and rights-of-way after service collection.

The Council may also consider alternatives/amendments to the proposed ordinance.

Section 3. A new section is added to chapter 7.42 of the Shohomish County Code to read:

7.42.045 Set out of containers.

No collection container shall be kept or stored within the confines of any public right-of-way in a residential area (urban/suburban or rural). Collection containers shall be kept on private property in a convenient and accessible location preferably near the residence without interfering with the reasonable enjoyment of such private property or adjoining property.
