PROPOSED ORDINANCE NO. 22-060

AUTHORIZING THE SNOHOMISH COUNTY EXECUTIVE TO SIGN ON BEHALF OF SNOHOMISH COUNTY AN INTERLOCAL AGREEMENT BETWEEN SNOHOMISH COUNTY AND SNOHOMISH HEALTH DISTRICT

WHEREAS, the Snohomish Health District was incorporated in 1959 as an independent special purpose district for public health in Snohomish County; and

WHEREAS, since its formation, Snohomish County and Snohomish Health District have worked together in a collaborative manner to address public health issues and concerns; and

WHEREAS, in 2009, Snohomish County and Snohomish Health District, working in collaboration with other partners, responded to hundreds of H1N1 cases and ultimately vaccinated over 26,000 people; and

WHEREAS, during the State Route 530 landslide event in 2014, Snohomish County and Snohomish Health District staff worked to provide support to the medical examiner's office, assess environmental health concerns such as water contamination, and ensure responder safety, hygiene, and decontamination; and

WHEREAS, in 2017, Snohomish Health District participated in a collaborative effort with representatives of the County Executive's Office, County Council, and Sheriff's Office to address the opioid epidemic; and

WHEREAS, on January 20, 2020, the Snohomish County Department of Emergency Management (DEM) and Snohomish Health District quickly activated unified incident command upon notification of the first confirmed COVID-19 case in the United States; and

WHEREAS, through unified command, Snohomish County DEM and Snohomish Health District established protocols for isolation and quarantine, coordinated advanced planning for personal protective equipment distribution, medical-surge operations, and community-care coordination; and

WHEREAS, Snohomish County Vaccine Task Force, working in close and continuous collaboration with Snohomish Health District, planned, executed, and maintained no less than seven mass vaccination sites and coordinated dozens of mobile vaccination clinics focused on residents adversely impacted by COVID-19 due to racial, ethnic, transportation, economic, mobility, and technology disparities. This effort ultimately resulted in more than 1,000,000 doses being administered; and

WHEREAS, by working together as one, the County and public health professionals have increased opportunities to:

- (a) Secure resources to address the effects of climate change, water quality, and the built environment on public health-related outcomes in Snohomish County and the surrounding region,
- (b) Commit to modernizing all applicable regulatory codes and policies governing environmental health practices.
- (c) Restore needed clinical and non-clinical services, improving access to care for the residents of Snohomish County,
- (d) Obtain resources for local public health and have unity of purpose to improve health related outcomes in the community; and

WHEREAS, the Snohomish County Executive memorandum dated May 24, 2022, commits to moving the Health District in whole, retaining its independence, and strengthening the health of all Snohomish County residents; and

WHEREAS, pursuant to RCW 70.46.090, Snohomish County may withdraw from membership in Snohomish Health District and immediately establish a health department to provide health service standards promulgated by the state board of health for administration of public health programs in Snohomish County; and

WHEREAS, pursuant to RCW 70.05.130, Snohomish County is responsible for expenses required for local public health services; and

WHEREAS, pursuant to Snohomish Health District Board of Health Resolution 22-16, dated May 31, 2022, the Board of Health voted unanimously to support Snohomish County's withdrawal from Snohomish Health District and committed to partnering over the remainder of the year to transition all public health services, assets, employment contracts, and related matters to Snohomish County government; and

WHEREAS, pursuant to Motion 22-248, the County Council voted to authorize issuance of a notice of intent to withdraw from the District with a withdrawal date of December 31, 2022 with the intent to form a unified County health department and has timely provided such notice to the District as required by RCW 70.46.090;

WHEREAS, the County now intends to withdraw from the Snohomish Health District on December 31, 2022, and immediately thereupon establish a county health department;

WHEREAS, the Transfer of public health authority and operations shall occur on December 31, 2022 ("Transfer Date") and, upon that date, the County's newly established health department will provide health services which shall meet the standards for health services promulgated by the state board of health as required by RCW 70.46.090;

WHEREAS, the County and the District have negotiated the terms and conditions by which they will cooperatively work toward the transfer of public health authority from the District to the County and provide for the transfer of operations to the County, including but not limited to the employment of District employees within the County health department, the conveyance of District assets to the County, the assignment of all contracts and agreements, the assignment of all permits or other regulatory permissions, and the transfer or other disposition of District liabilities and obligations:

NOW, THEREFORE, BE IT ORDAINED:

Section 1. The County Council hereby adopts the foregoing recitals as findings of fact and conclusions as if set forth in full herein.

Section 2. The Snohomish County Council hereby approves and authorizes the Snohomish County Executive, or designee, to sign the "Interlocal Agreement between Snohomish County and

Snohomish Health District," substantially in the form attached hereto as Exhibit A. The Snohomish County Council authorizes the Snohomish County Executive, or designee, to sign all documents necessary to effectuate the Interlocal Agreement and the transfer of public health authority and operations from the District to the County, including any such amendments as negotiated between the parties pursuant to Section 2.0 of the Interlocal Agreement, and further ratifies any documents previously executed by the Snohomish County Executive, or designee, in furtherance of effectuating the Interlocal Agreement.

The Council may also consider alternatives/amendments to the proposed ordinance.
