Background: On June 8, 2022, the Snohomish County Council unanimously approved a motion to integrate the Snohomish Health District and Snohomish County effective January 1, 2023. Numerous sections of Snohomish County Code reference the Snohomish Health District and/or variations of this phrase. To ensure an orderly transition and maintain the ability to enforce regulations, references to health district need to be amended and changed to the county health department.

A summary of the proposed ordinance is as follows:

Section 1. Adopts findings of fact.

Section 59. Provides a standard severability and savings clause.
