Based on our site walk with Loren Swanson and Josh Grindy Siemens will relocate 2 panels and all associated wire to the new location above the elevator lobby. This will result in the main panels and power supplies located in the 2nd and 3rd floor Telcom rooms to be relocated to the 3rd floor interstitial.

Overall Scope

2nd Floor Panel:

Relocate Main panel and all associated wiring to new location above elevator lobby

- Install new low voltage conduit and wire from 2nd floor panel to new location
- Core drill through floor in 3rd floor interstitials
- Install new 120 vac conduit and wire to panel and power supplies
- Install terminal strips in existing cabinet to connect to new location
- Dress and connect all existing circuits in existing panel to new location
- Update record drawings at end of project
- Provide project materials including conduit, low voltage wire, high voltage wire, terminal strips

3rd Floor Panel:

- Install new low voltage conduit and wire from 3rd floor panel to new location
- Install new 120 vac conduit and wire to panel and power supplies
- Install terminal strips in existing cabinet to connect to new location.
- Dress and connect all existing circuits in existing panel to new location
- Update record drawings at end of project
- Provide project materials including conduit, low voltage wire, high voltage wire, terminal strips


