- SiPass matches Snohomish County standard and will communicate with the existing county security server with existing software licensing.

SCOPE OF WORK

- > Expand existing SiPass Panel #1 & #2 to incorporate three (3) new card reader doors.
- Provide and install field devices for (3) new full package access control doors at remodeled door locations. (CR, REX & Door Position Switch).
- > Provide and install surface mounted conduit at locations that must be surface mounted due to concrete structure.
- All security low voltage cabling has been installed by Forma Construction. Cabling currently routes from each new card reader door to the access controller panels.
- > All work to be done during normal working hours (7am-5pm M-F).
- > As-Build Security Drawings will be modified to incorporate new card reader doors.
