12 AN ORDINANCE APPROVING THE 2023 ANNUAL CONSTRUCTION PLAN FOR COUNTY
13 TRANSPORTATION IMPROVEMENTS

15 WHEREAS, RCW 36.81.130 calls for the county road engineer to file with the county
16 legislative authority, for consideration and adoption, a plan for the laying out, construction and
17 maintenance of all county roads for the ensuing fiscal year; and

19 WHEREAS, the Snohomish County Engineer has submitted the 2023 Annual Construction
20 Plan for Transportation to the County Council for consideration in accordance with RCW 36.81.130;

23 WHEREAS, the 2023 Annual Construction Plan for Transportation is attached hereto as
24 Exhibit A; and

26 WHEREAS, this annual construction plan conforms as nearly as practicable to the County's
27 long-range road program and comprehensive plan as contained in the 2023-2028 Six-Year
28 Transportation Improvement Program, adopted November 9, 2022, by Motion No. 22-414, and in
29 the Transportation Element for the Snohomish County Comprehensive Plan, adopted on June 10,
30 2015, in Amended Ordinance No. 14-137; and

32 WHEREAS, the 2023 Annual Construction Plan for Transportation meets all other
33 requirements set forth in RCW 36.81.130.

35 NOW, THEREFORE, BE IT ORDAINED:

37 Section 1. The Snohomish County 2023 Annual Construction Plan for Transportation for the
38 laying out, construction, and maintenance of county roads, attached hereto as Exhibit A, as
39 submitted by the Snohomish County Engineer, is hereby approved and adopted pursuant to RCW
40 36.81.130 and is, by this reference, incorporated herein and made a part hereof.
