Consideration:

Authorize the Executive to execute Amendment #1 and Amendment #2 to a contract with Anchor QEA, LLC for park and habitat related construction on the Meadowdale project.

Background:

Snohomish County purchased the property known as Meadowdale Beach County Park in 1968 with the intent to create a public park that has beach access. In furtherance of this goal, Snohomish County entered into an agreement with BNSF in 1987 to allow the County to have shared-use of the culvert that coveys Lunds Gulch Creek, a salmon bearing stream under the railroad embankment within the railroad's right-of-way the County installed a wooden boardwalk (later steel grating) above the stream within the tunnel for pedestrian access to the beach in 1988.

Over time, changes within the watershed resulted in flooding issues and accumulation of gravel at the culvert entrance hampering fish passage and pedestrian access. Through a public process the County developed a plan to replace 128 feet of railroad embankment with a railroad bridge, create an estuary for salmon habitat, provide a separated ADA-accessible path for pedestrian beach access, install picnic areas, a footbridge, and interpretive signage.

Council approved a contract with Anchor QEA, LLC on April 14, 2021 for park and habitat related construction services for the Meadowdale project with an initial budget of \$790,534.48.

Scope:

Motion 22-457 // Amendment #1 – Additional services include:

- Construction Services Contract Admin. Provide additional coordination with other parties involved in the project; increase effort for submittal's; RFI tracking; change management; and monthly pay requests.
- Construction Services Field Provide additional oversight of the project due to it extending from one season to two and develop/maintain a permit tracking spreadsheet.
- Civil Engineering and Design Support Provide additional design to plans for demolition of the picnic shelter, site for the new shelter, and additional topographical survey support.

Motion 22-485 // Amendment #2 – Additional services include:

 Civil Engineering and Design Support – Design and engineering services provided by Salt Studios and Swenson Say Faget for the new 20x30 picnic shelter.
