**Background:** The County purchased COVID-19 Antigen Test Kits using ARPA funding and the County is eligible to apply for FEMA funds to cover the cost. The proposed ordinance will allow the County to sign an agreement with the Washington State Military Department and FEMA for the reimbursement of the COVID-19 Antigen Test Kit expenses. These funds were not anticipated when Council adopted the 2022 budget.




