Consideration:

The proposed motion would approve and authorize the execution of Amendment 10 to the integrated financial management system contract with Cayenta, a division of N. Harris Computer Corporation.

Background:

In 1996 the County selected Cayenta Canada Corporation, formerly SFG Technologies, Inc., through RFP-01-95 to install and implement an enterprise integrated financial management software system. Cayenta's integrated financial management system software is the current standard for enterprise electronic financial systems and provides critical operations and fiscal accountability necessary for County operations.

In September 2021 the County approved Motion 21-315 to upgrade the database platform from Oracle to SQL. The upgrade included database transition and additional licensing components and subscriptions for the upgraded software as well as continued maintenance and support into the future. During implementation, the County determined that the Miscellaneous Receivables portion of the upgrade was not required, which results in a license credit of \$5,000 and a related reduction ongoing support fees.

Current Proposal:

Scope: The proposed Amendment No. 10 to the Master Contract will memorialize the \$5,000 license credit and the related reduction in ongoing license maintenance and support fees.

Duration: Amendment 10 start date of August 28, 2022, through December 31, 2023.

Fiscal Implications: The license was paid in 2021, and the credit will be applied to the Classic Accounts & Receivables enhancement work as part of the implementation professional services contract, as memorialized in change order CO-003. Amendment 10 memorializes the \$5,000 license credit and the related reduction in ongoing license maintenance and support fees, with a total savings of \$6,250.
