**Background:** This ordinance adopts amendments to Snohomish County Code relating to Solid Waste disposal. The ordinance revises language to provide greater specificity related to restrictions on the acceptance of wastes at solid waste facilities.

**A summary of the proposed ordinance is as follows:**

PROPOSED ORDINANCE NO. 22-068

RELATING TO SOLID WASTE DISPOSAL; AMENDING CHAPTERS 7.35 AND 7.41 SCC

Sections 1 – 7.35.125 Disposal of Solid Waste. Amends Snohomish County Code Section 7.35.125 subsection 6 (d) to add language which establishes a minimum container weight of 23 tons for Residual Reclamation Waste (RRW) delivered to the intermodal yard. This adjustment is intended to maximize container transport through the rail system, create more efficient use of the waste export system and RRW customer workflow and operations.

Sections 2 – 7.41.020 Solid Waste Disposal Service Fee Schedule. Amends Snohomish County Code Section 7.41.020, subsection (6) to add language to clarify that the household hazardous waste program is intended for residents of unincorporated Snohomish County and municipal corporations within the County which have an interlocal agreement for solid waste services. The current language is not clear.

Sections 3 – 7.41.050 Restrictions on acceptance of wastes. Amends Snohomish County Code Section 7.41.050, subsection (3) to add language to provide greater specificity related to the acceptance of wastes at solid waste facilities. The specified restrictions include sewer/wastewater treatment plant screenings and electronic wastes.

The Council will also consider a proposed amendment adding a separate start date for sewer and wastewater treatment plant screenings.

At the hearing, the Council may also consider additional alternatives/amendments to the proposed ordinance.




