Consideration:

Approve two (2) intergovernmental agreements with the Alderwood Water & Wastewater District relating to utility construction associated with two (2) Fish Passage Culvert Replacement projects.

Background:

In 2016 Council approved Ordinance [16-003](#), granting non-exclusive water and sewer franchise/limited use of the public road rights of way to Alderwood Water & Wastewater District. The agreement stipulates it is the District’s responsibility to relocate its infrastructure when necessary to accommodate county initiated public improvements in the County’s right of way.¹

The 2022 budget included over \$7 million dollars for fish passage/culvert replacement projects to be expended over the coming years. As a result of this 2022 funding, 14 new fish passage/culvert replacement projects were included in the 2023 SWM ACP.²

Two of these projects are in areas that impact Alderwood Water & Wastewater District’s infrastructure within the County’s right of way under the above referenced franchise. While it is the District’s responsibility to move their infrastructure at their own cost, the parties have determined that it is in the best public interest for the County to perform the relocation of that infrastructure during construction of the project and be reimbursed by the District the infrastructure relocation work.
