WHEREAS, the Director of the Department of Public Works has prepared the attached revised service fee schedule to provide for full cost recovery;

NOW, THEREFORE, ON MOTION, the Snohomish County Council approves the attached Solid Waste Division Service Fee Schedule to become effective January 1, 2023.
