WHEREAS, in June 2007, the Snohomish County Council approved construction of the Swanson Road Bridge #80 Replacement Project (RC1105); and

WHEREAS, in order for this project to be constructed, a Critical Area Study was prepared dated March 2007 as part of the regulatory permit process; and

WHEREAS, the Critical Area Study called for a designated protection site that would be left permanently undisturbed in a substantially natural state for compensatory mitigation of the project's impacts to critical areas; and

WHEREAS, parcel 31060900302500 was chosen for the critical area impact mitigation site to be protected in perpetuity; and

WHEREAS, in order to permanently protect this property, a Critical Area Site Plan is required to be approved by the Snohomish County Council and recorded with the Snohomish County Auditor;

NOW, THEREFORE, ON MOTION, the Snohomish County Council hereby authorizes the critical area protection on County property as shown on the Critical Area Site Plan as attached hereto and incorporated by reference herein and authorizes the County Executive to execute the same.


