APPROVING AND AUTHORIZING THE COUNTY EXECUTIVE TO EXECUTE THE RIGHT-OF-WAY PLAN FOR THE SWAMP CREEK BRIDGE #503 REPLACEMENT PROJECT; RC1420; UPI# 17-0009

WHEREAS, the Snohomish County Council has adopted the 2022 ACP which includes the Swamp Creek Bridge #503 Replacement project as item F.54; and

WHEREAS, Snohomish County Council's approval of the Right-of-Way Plan for the Swamp Creek Bridge #503 Replacement project will allow Public Works to proceed with acquisition and purchase of the necessary Right-of-Way;

NOW, THEREFORE, ON MOTION, the Snohomish County Council approves the following actions:

<u>Section 1.</u> Approval of the Right-of-Way Plan for the Swamp Creek Bridge #503 Replacement project as attached hereto and incorporated by reference herein, and authorizes the County Executive to execute the same.

<u>Section 2.</u> Authorizes the Public Works Director to approve appraisal and appraisal review contracts necessary to implement the plan, in an amount not exceeding \$39,000, provided that sufficient appropriation authority exists, and all attendant documents for completion thereof.

<u>Section 3.</u> Authorizes the County Engineer to acquire uneconomic remnants or additional impacted property necessary to implement the plan and all attendant documents for completion thereof.

<u>Section 4.</u> Authorizes the County Engineer to make revisions to the plan and to approve and sign a revised Right-of-Way Plan to provide for design revisions and to document uneconomic remnants or additional impacted property acquired.




SWAMP CREEK BRIDGE #503
