AUTHORIZING THE COUNTY EXECUTIVE TO SIGN THE 2023-2025 ON-CALL CONSULTANT SERVICES MASTER AGREEMENTS FOR THE ENVIRONMENTAL SERVICES DISCIPLINE

WHEREAS, the Department of Public Works has determined the need for consultant services on an on-call as-needed basis for emergency projects, time critical projects, and for elements of projects where the required expertise and/or staffing is not available: and

WHEREAS, the current 2019-2022 On-Call Consultant Services program expires as of December 31, 2022; and

WHEREAS, the Thirty-two (32) highest ranking consultants responding to RFQ-06-22, under the Engineering Services discipline, as shown in Exhibit A, were selected through established Federal, State and County policies and practices; and

WHEREAS, Council's approval of the 2023-2025 On-Call Consultant Services Master Agreements for Engineering Services will allow the Department of Public Works to meet County goals as related to the approved Annual Construction Programs (ACP) and to provide services to other County departments on an on-call basis;

NOW, THEREFORE, ON MOTION, the Snohomish County Council approves and authorizes the County Executive to sign the 2023-2025 On-Call Consultant Services Master Agreements for the Engineering Services discipline with an umbrella amount not to exceed \$22,555,000.00, and further authorizes the Director of Public Works or designee to approve administrative Supplements and Task Assignments issued under the Master Agreements, provided that sufficient appropriation authority exists.
