PROPOSED ORDINANCE NO. 22-071

RELATING TO THE SNOHOMISH COUNTY FLOOD DAMAGE REDUCTION GRANT PROGRAM; AUTHORIZING THE EXECUTIVE TO EXECUTE AMENDMENT NO. 2 FOR FRENCH SLOUGH FLOOD CONTROL DISTRICT INTERLOCAL AGREEMENT

WHEREAS, the County has established a Flood Damage Reduction Grant Program under which it provides grant funds for the repair of certain facilities owned, operated, and/or maintained by special purpose flood control districts, such as the French Slough Flood Control District (“the District”); and

WHEREAS, the District manages its flood control and protection facilities to improve farming and use of agricultural land along Snohomish County rivers and to drain flood waters after major floods and the Snohomish County Council (“County Council”) recognizes the importance of repairing damage to these flood control and protection facilities; and

WHEREAS, the County and the District, as authorized through Ordinance No. 21-017, entered into an Interlocal Agreement to provide grant funding to the District for the District’s Lower Pilchuck Levee Rehabilitation project; and

WHEREAS, through a first amendment to the Interlocal Agreement dated December 3, 2021, the County and the District extended the expiration date of the Interlocal Agreement to December 31, 2022; and

WHEREAS, the County and the District wish to extend the expiration date of the Interlocal Agreement to December 31, 2023, through Amendment No. 2; and

WHEREAS, Amendment No. 2 also authorizes the Director of the Snohomish County Department of Conservation and Natural Resources to approve and execute a written amendment with the District to extend or renew the Interlocal Agreement for up to one additional one-year term; and

WHEREAS, the County Council held a public hearing on _____, 2022, to hear public comment and consider approving Amendment No. 2 of the French Slough Flood Control District Interlocal Agreement.

NOW, THEREFORE, BE IT ORDAINED:

Section 1. The County Council hereby adopts the foregoing recitals as findings of fact and conclusions as if set forth in full herein.

Section 2. The County Council authorizes the County Executive to execute Amendment No 2 to the Interlocal Agreement between Snohomish County and French Slough Flood Control District for Flood Damage Reduction in the form set forth as Exhibit A hereto.

At the hearing, the Council may consider additional alternatives/amendments to the proposed ordinance.




