#### PROPOSED ORDINANCE NO. 22-063

GRANTING A NON-EXCLUSIVE FRANCHISE AUTHORIZING LIMITED USE OF THE PUBLIC ROAD RIGHTS-OF-WAY IN PORTIONS OF SNOHOMISH COUNTY, WASHINGTON TO INTERMOUNTAIN INFRASTRUCTURE GROUP, LLC.

Intermountain Infrastructure Group, LLC, a special purpose district, has applied to Snohomish County, Washington, for a non-exclusive franchise to construct, maintain, operate, replace and repair telecommunication systems in, on, across, over, along, under, and/or through public rights-of-way within the following portions of unincorporated Snohomish County:
