#### PROPOSED ORDINANCE NO. 22-064

GRANTING A NON-EXCLUSIVE FRANCHISE AUTHORIZING LIMITED USE OF THE PUBLIC ROAD RIGHTS-OF-WAY IN UNINCORPORATED SNOHOMISH COUNTY, WASHINGTON TO T-MOBILE WEST, LLC

T-Mobile West, LLC, a Delaware corporation, has applied to Snohomish County, Washington, for a non-exclusive franchise to construct, maintain, operate, replace and repair telecommunications systems in, on, across, over, along, under, and/or through public rights-of-way within unincorporated Snohomish County.

If approved, proposed Ordinance No. 22-064 would grant said franchise to T-Mobile, LLC, subject to all of the terms and conditions contained in the ordinance.

If approved, the franchise would go into effect following enactment of the ordinance, acceptance by T-Mobile, LLC, provision of evidence of insurance, and payment of all applicable fees. The maximum term of the franchise would be twenty (20) years from the effective date.
