The alternates, one from each council district and two at-large alternates, shall each serve in the absence of the member for whom they are the alternate. Members and alternates shall be residents of Snohomish county. No more than two members and no more than two alternates may reside in any single council district.))The arts commission shall be composed of eleven members. Five members to include at least one from each council district. These five members shall represent the council districts, and each shall reside in the district the member represents. Six members shall serve at-large and may reside anywhere within the county, so long as no more than three at-large members reside in the same council district. Appointments and terms shall be pursuant to chapter 2.03 SCC. (((2) The two at-large members and their alternates shall be appointed by the executive and the five members and their alternates shall be appointed by the county council. Council appointees shall be nominated by each council member, and not by any other council member, and confirmed by the council. The county executive may recommend names for appointment by the councy council.))

Thereafter, appointments shall be made for four-year terms. ((The terms of alternates shall be coterminous with the terms of the members for which they serve as alternates.)) All appointees shall serve until their successors are appointed.
