RELATING TO THE ELECTION EQUIPMENT CUMULATIVE RESERVE FUND 189; AMENDING CHAPTER 4.73 SCC

<u>Section 1.</u> Snohomish County Code Section 4.73.010, enacted by Ordinance 89-140 on November 13, 1989, is amended to read:

4.73.010 Name of Fund

There is hereby created a special revenue fund named Elections ((Equipment)) Cumulative Reserve Fund.

<u>Section 2.</u> Snohomish County Code Section 4.73.020, last amended by Ordinance 02-029 on July 10, 2002, is amended to read:

4.73.020 Purpose of fund.

The elections ((equipment)) cumulative reserve fund is established to accumulate monies collected by the county auditor's office for conducting elections, maintaining voter registration files, and producing a local voters' pamphlet. These monies represent a portion of the billings that is intended to recapture the cost of ((equipment and software purchased and used in)) conducting elections, maintaining voter registration files and producing a local voters' pamphlet by the county auditor. The money in this fund will be used ((te))for the acquisition of, or construction or improvements to, real property necessary to conduct elections, or to purchase equipment, hardware, durable supplies and software used by the county auditor's office for elections, voter registration and local voters' pamphlet operations.

<u>Section 3.</u> Snohomish County Code Section 4.73.030, last amended by Ordinance 02-029 on July 10, 2002, is amended to read:

4.73.030 Fund operation

The funds collected by the county auditor's office for the purposes described in SCC 4.73.020 shall be deposited in the elections ((equipment)) cumulative reserve fund. Any unspent monies shall be carried over within the fund from year to year. The ending fund balance and anticipated revenues shall be budgeted annually in conjunction with the county budget process prior to any expenditure from the fund.

<u>Section 4.</u> Snohomish County Code Section 4.73.040, last amended by Ordinance 02-029 on July 10, 2002, is amended to read:

4.73.040 Fund resources.

((RCW 29.07.030, 29.13.045, 29.13.047 and 29.81A.070))RCW 29A.04.410, 29A.04.420, 29A.08.150, and 29A.32.270 authorize the county auditor to recapture the prorated cost of conducting elections, maintaining voter registration files and producing a local voters' pamphlet. The billing process for recapturing these costs allows for an overhead charge to be placed on all direct costs associated with conducting elections, maintaining voter registration files and producing a local voters' pamphlet for other governments. The monies representing this overhead charge shall be deposited in the elections ((equipment)) cumulative reserve fund for the purposes described in SCC 4.73.020.

<u>Section 5.</u> Snohomish County Code Section 4.73.050, last amended by Ordinance 02-029 on July 10, 2002, is amended to read:

4.73.050 Fund manager.

The county auditor or ((his))the auditor's designee shall be charged with the responsibilities described in SCC 4.05.050.

At the hearing, Council may consider alternatives/amendments to the proposed ordinance.
