WHEREAS, Snohomish County has secured Coronavirus Local Fiscal Recovery (CLFR) grant funds under the federal American Rescue Plan Act (ARPA); and

WHEREAS, the Executive Office of Snohomish County created the Office of Recovery & Resilience (ORR) to aid in the distribution of the ARPA funds; and

WHEREAS, both the County and the Public Facility District (PFD) of Lynnwood are public agencies under chapter 39.34 RCW; and; and

WHEREAS, RCW 36.01.085 states that economic development programs are a public purpose for counties in Washington state; and

WHEREAS, RCW 35.57.020 authorizes the PFD to acquire, own, remodel, maintain, equip, repair, finance, and operate regional centers; and

WHEREAS, the County recognizes the PFD of Lynnwood is important to economic development in Snohomish County; and
