APPROVING THE INTERAGENCY AGREEMENT WITH DEPARTMENT OF ECOLOGY FOR THE POLLUTION PREVENTION ASSISTANCE PROGRAM

WHEREAS, the Snohomish Health District was integrated into Snohomish County effective December 31, 2022, and now operates as the Snohomish County Health Department; and

WHEREAS, prior to its integration into Snohomish County, the Snohomish Health District entered into an interagency agreement with the Washington State Department of Ecology for the Snohomish Health District to provide pollution prevention assistance work; and

WHEREAS, the Washington State Department of Ecology and the Snohomish County Health Department wish to continue this partnership through June 30, 2023; and

WHEREAS, the County Council held a public hearing on March 22, 2023, to enter into this agreement attached as Exhibit A.

NOW, THEREFORE, BE IT ORDAINED:

Section 1. The County Council hereby adopts the foregoing recitals as findings of fact and conclusions as if set forth in full herein.

Section 2. The County Council hereby approves and authorizes the County Executive, or designee, to execute the interagency agreement between Snohomish County and the Washington State Department of Ecology for pollution prevention assistance in substantially the form as attached hereto as <u>Exhibit A</u>.
