### APPROVING AGREEMENT WITH WASHINGTON STATE DEPARTMENT OF SOCIAL AND HEALTH SERVICES TO ASSIST RECIPIENTS OF TEMPORARY ASSISTANCE FOR NEEDY FAMILIES THROUGH THE WORKFIRST PROGRAM

WHEREAS, the Snohomish Health District was integrated into Snohomish County effective December 31, 2022, and now operates as the Snohomish County Health Department; and

WHEREAS, prior to its integration into Snohomish County, the Snohomish Health District entered into a program agreement with Washington State Department of Social and Health Services to assist recipients of Temporary Assistance for Needy Families (TANF) to meet their goals and provide well-being for their family through the WorkFirst Program; and

WHEREAS, the Washington State Department of Social and Health Services and the Snohomish County Health Department wish to continue this partnership; and

WHEREAS, the County Council held a public hearing on \_\_\_\_\_\_, 2023, to consider approving the program agreement with Washington State Department of Social and Health Services and to authorize the Snohomish County Executive to enter into such agreement in substantially the form attached as Exhibit A;
