RELATING TO THE 2023 BUDGET; MAKING A SUPPLEMENTAL APPROPRIATION IN HUMAN SERVICES FUND 124 TO PROVIDE EXPENDITURE AUTHORITY FOR RENTAL AND UTILITY ASSISTANCE

Summary: The proposed ordinance authorizes a supplemental appropriation in the 2023 Budget in the amount of \$31,418,515 in Human Services Fund 124 to provide expenditure authority for funds received from the American Rescue Plan Act of 2021 through the Washington State Department of Commerce for the Commerce Eviction Rent Assistance Program 2.0. The grant funds will prevent evictions by providing payment for rental and utility assistance for low-income residents impacted by the pandemic.
