Section 2. Finds that Pacific Ridge is the fee owner and intends to deed the real property described in Section 3 for the use of the public as a County road in perpetuity and that a statutory warranty deed has been executed and submitted to accomplish the same.

Section 3. Provides the full legal description and establishes the new County road right-of-way subject to the full County authority and discretion, subject to the conditions in Section 7:

Section 4. Requires Pacific Ridge to construct the road to County design standards at its own expense and provide a two-year maintenance security.

Section 6. Authorizes the Snohomish County Executive to accept the Statutory Warranty Deed on behalf of the County.

Establishment of the County right-of way is not effective until: (1) DPW files a certification with the Clerk of the County Council stating all required administrative and advertising costs pursuant to SCC 13.90.070 have been paid; (2) PDS and DPW have inspected and accepted final construction of 188th St SW; (3) a two-year maintenance security has been submitted and accepted by the County; and (4) the Statutory Warranty Deed has been recorded.
