### AUTHORIZING THE COUNTY EXECUTIVE TO EXECUTE A CONTRACT WITH QUADIENT LEASING USA, INC. PURSUANT TO RFP-22-037BC-S FOR MAIL MACHINES AND ONLINE MAILING SERVICES AT SNOHOMISH COUNTY AIRPORT

WHEREAS, the Snohomish County Airport desires to contract with Quadient Leasing USA, Inc. ("Quadient") for mailing equipment and online services for continuation of billing and business activities; and

WHEREAS, the Airport needs to renew and upgrade its current leasing contract for mailing machines and online mailing software services including on-call repair service and routine maintenance of their machines; and

WHEREAS, Quadient was selected as the top candidate via the competitive bidding process under RFP 22-037BC-S; and

WHEREAS, Quadient shall supply a new mailing machine, letter opener, and online software services for \$285.93 per month for sixty (60) months totaling \$17,155.80, plus postage and other user fees which could add up to \$10,000.00 per year based on the airport's business mailing needs of that year;

NOW, THEREFORE, ON MOTION, the Snohomish County Council approves and authorizes the Snohomish County Executive to sign a contract with Quadient Leasing USA, Inc. for \$17,155.80, plus postage and other user fees that are based on the amount used that could add up to \$10,000.00 per year in the form attached hereto.


