RECITALS

- A. Whereas, the County and Aurigo Software Technologies, Inc. are the parties to that certain Software Subscription and Services Master Agreement (the "Agreement") executed on May 30, 2018; and
- B. Whereas, the Exhibit C Statement of Work, Phase 2 Configuration and Implementation states that the Contractor shall submit to the County a detailed Requirements Analysis Report and Implementation Plan/ Statement of Deliverables based on the knowledge gained and work completed in Exhibit C, Phase 1, to be incorporated into the Agreement as Appendix 1 to Exhibit C when accepted by Snohomish County; and
- C. Whereas, the Contractor submitted and the County accepted the Statement of Deliverables on September 9, 2018; and
- D. Whereas, during the implementation and User Acceptance Testing (UAT) of the Statement of Deliverables (SOD), the County determined that additional functionality was needed that was not included in the original Agreement and Statement of Deliverables; and
- E. Whereas, the Contractor is prepared to perform the requested services and has submitted a fair and reasonable proposal to perform the services, and the County wishes to accept the Contractor's proposal; and

AGREEMENT

NOW, THEREFORE, in consideration of the covenants hereinafter set forth and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the County and Contractor agree as follows:

1. The Aurigo Masterworks Implementation Statement of Deliverables, attached hereto, is hereby incorporated by this reference into the Master Agreement as Appendix 1 to Exhibit C, Statement of Work.

1 Scope of Services

During the User Acceptance Testing (UAT) of the Implementation Lifecycle, Snohomish Subject Matter Experts (SMEs) logged feedback that was agreed by the County and Contractor to be either a feature request or an enhancement. These items are listed below. These features and enhancements are not part of the original signed Statement of Deliverables Functional Specifications or the Master Agreement. Snohomish County now desires to add these features and enhancements as an amendment to the Master Agreement.

Aurigo shall perform the following tasks as set forth in the "Details" column of Table 1 to this Exhibit D

- Prices above are exclusive of the followings services
 - o Integration and Data Migrations services
- Aurigo shall address Issues/Bugs raised within 30 days from the final go-live on priority with no additional cost.
- 50% is payable on execution of Amendment No. 1, with the balance payable on acceptance.
