4.130.010 Name of fund.

There is hereby created a public works construction fund.

4.130.020 Purpose of fund.

The purpose of the public works projects fund is to provide funding and support for land acquisition, design services, permitting, and construction related to major public works construction projects.

4.130.030 Sources of resources.

Resources of the public works construction fund shall be from appropriation, gift, bequest, bond proceeds or other available financing sources.

4.130.040 Fund manager.

The director of the department of public works or his/her/their designee shall serve as the fund manager, whose name and title shall appear on the master list of fund managers maintained in the department of budget and finance.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.




