<u>Summary:</u> The proposed ordinance approves Amendment No. 1 to extend the Interlocal Agreement with Community Transit to implement the Commute Trip Reduction (CTR) Plans and Programs through June 30, 2025. Pursuant to RCW 70A.15.4020, the County is required to develop and adopt a commute trip reduction (CTR) plan for major employers affected in unincorporated growth areas to reduce commuter vehicle miles traveled and reduce single-occupant vehicle trips in the county to help decrease traffic congestion, mitigate air pollution levels, fuel consumption, noise, and energy use.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.
