AMENDMENT NO. 5 TO THE SOFTWARE SUBSCRIPTION AND SERVICES AGREEMENT BETWEEN SNOHOMISH COUNTY AND AURIGO SOFTWARE TECHNOLOGIES, INC.

This Amendment No. 5 to the Software Subscription and Services Agreement between Snohomish County and Aurigo Software Technologies, Inc. ("Amendment No. 5") is entered by and between Snohomish County, a political subdivision of the State of Washington (the "County"), and Aurigo Software Technologies, Inc., incorporated under the laws of the State of Texas (the "Contractor" or "Aurigo").

RECITALS

- A. The County and Aurigo Software Technologies, Inc. are the parties to that certain Software Subscription and Services Master Agreement (the "Agreement") executed on May 30, 2018;
 - B. To date the County and Aurigo have completed four amendments; and
- C. The County and Aurigo wish to amend the Agreement to extend services through August 31, 2028.

NOW, THEREFORE, in consideration of the covenants hereinafter set forth and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the County and Contractor agree as follows:

- 1. Aurigo agrees to provide to the County five years of additional software subscription to the County from the subscription anniversary date through August 31, 2028, as set forth in Appendix 1 to Exhibit D.
- 2. Section 5. A. of the Agreement (Term of Agreement) is amended to read as follows:
 - **A. Term of Agreement.** This Agreement shall commence on May 30, 2018, and terminate on August 31, 2028, with the subscription anniversary date on September 1 of each year.
- 3. Aurigo agrees to provide Gold Support Plan services to the County from the subscription anniversary date through August 31, 2028 as set forth in Appendix 1 to Exhibit D.
- 4. Section 7 B of the Agreement shall be amended to read as follows:B. The County shall, upon receipt of appropriate documentation, compensate the Contractor for the Contractor's services pursuant to the fee schedule set

forth in Exhibit D. Annual Subscription Fees and Gold Support Services Fees are set forth in Appendix 1 to Exhibit D, by this reference incorporated herein. Payment shall be made on a Net Thirty (30) day basis. This is a "Fixed-Price" contract based upon the deliverables identified in Exhibit A and Exhibit C.

Except as expressly provided in this Amendment No. 5, all of the terms and conditions of the Agreement remain in full force and effect.
