MOTION NO. 23-178

APPROVING THE APPORTIONMENT OF  
2022 PUBLIC UTILITY DISTRICT PRIVILEGE TAXES

WHEREAS, Snohomish County has received the amount of \$7,533,430.63 from the State of Washington for Snohomish County Public Utility District No.1, privilege taxes; and

WHEREAS, RCW 54.28.090 authorizes the County Council to stipulate the distribution of said funds subject to certain limitations; and

WHEREAS, the County Council has determined that these funds should be distributed as set forth below; and

NOW, THEREFORE ON MOTION, Snohomish County Council hereby authorizes and directs the Snohomish County Treasurer to distribute \$2,934,170.58, representing 3/4 of 1% of revenue derived from the cities and towns to the cities and towns in accordance with the schedule below, and to deposit the balance, \$4,599,260.05, into the General Fund.
