AMENDMENT NO. 1 TO THE SOFTWARE LICENSE AND SERVICES AGREEMENT FOR PETTRACK SYSTEM SOFTWARE

THIS AMENDMENT NO. 1 TO THE SOFTWARE LICENSE AND SERVICES AGREEMENT FOR PETTRACK SYSTEM SOFTWARE ("Amendment No. 1") is entered into as of this 2/2 day of 20/2, by and between Snohomish County, a political subdivision of the State of Washington (the "County"), and Progressive Solutions, Inc., a California corporation ("PSI", "Contractor", or Licensor").

RECITALS

A. Whereas, the County and PSI are the parties to that certain "Software License and Services Agreement for PetTrack System Software" (the "Master Agreement") executed on January 11, 2013; and

B. Whereas, the parties desire for PSI to provide additional functionality to the system by installing 1) LicenseTrackTM, which will replace the need for existing Access applications, and 2) PetTrackTM Web Applications, which will enable pet owners to purchase new pet licenses in addition to renewals online; and

C. Whereas, the County desires to receive maintenance and support for these two additional software modules, synchronize the additional maintenance fees with the existing annual maintenance under the terms and conditions described in this Amendment No. 1; and

D. Whereas, the total cost of this Amendment No. 1, including Maintenance and Support through September 30, 2018, shall not exceed Twenty Four Thousand Six Hundred and Seventy Seven Dollars (\$24,677.00) plus applicable sales tax.

AGREEMENT

NOW, THEREFORE, in consideration of the covenants hereinafter set forth and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the County and PSI agree as follows:

Section 1. Exhibit B, Software License Agreement, Section IX ("License Fees and Payments"), is amended to add the following additional software licenses:
