RE: South Division Snohomish County District Court Judge Position

Dear Councilmembers Nehring, Dunn, Peterson, Mead, and Low,

I am writing to express my interest in being selected as the South Division District Court Judge for the Snohomish County District Court.

My experience qualifies me because of the breadth of my work; my regular practice in district courts, municipal courts, superior court, and administrative courts; and my experience as a *pro tem* judicial officer. I have direct experience as a *pro tem* in Snohomish County District Courts, including South Division court itself and the jail calendar which encompasses all District Courts. I also have experience as a *pro tem* in Edmonds, Everett, Lynnwood, and Monroe Municipal courts as well as King County Superior Court for juvenile dependency. In my tenure as a *pro tem* in District and Municipal Courts, I have presided over arraignments, trial confirmations, pre-trial hearings, mental health court, name changes, protective orders, criminal and civil motions, infractions, *ex parte* civil matters, small claims, and probation hearings in district and municipal courts. My *pro tem* work in King County has included contested 72-Hour Shelter Care Hearings, Family Treatment Court (FTC) therapeutic court hearings, juvenile dependency review hearings and motions, and others.

My practice has included court-appointed and private criminal practice in local courts of limited jurisdiction. Early in my career, I appeared as a Rule 9 Intern for the City of Everett in Everett Municipal Court, single-chairing multiple criminal jury trials and calendars, including the jail calendar. Once licensed, I began conflict appointed criminal defense representation. This included jury trials, motions, and all manner of calendars. These experiences allowed me to see municipal courts and criminal cases from both sides of the litigation spectrum.

I have other relevant litigation experience outside of criminal law. I have been court appointed and private counsel for protective orders in superior and district courts. I have substantial experience in juvenile dependency. I have represented many clients in family law, Worker's Compensation, BECCA Bill, and personal injury matters. In many cases, I was the sole practitioner in these areas of law in my office and I needed to use my resources – including legal research and attorney network – to solve problems on unique legal issues. This wide variety of experience in civil law is uniquely important for district court judges who are tasked with understanding civil procedure and hearing civil matters.

Additionally, my work for my law firm as a partner has given me a focus on administration. I coordinate budgets, adjust expenses, garner additional income, perform human resource tasks, and plan for long-term goals. This work has been an important reminder that legal practice does not only include issues related to the law, but also practical managerial issues of running an organization.

I am especially proud of my work, along with my colleagues, in the creation of the FIRST Legal Clinic. The legal clinic began as an idea in 2018 to provide representation to families at risk of CPS removal of newborns. The legal clinic officially began pro bono representation in July 2019 with an ultimate goal of funding the work. Using preliminary data from a few dozen clients, our team of three attorneys and one parent ally secured public, private, and legislative funding. After representing parents for free for two years, the legal clinic secured a legislative budgetary proviso for the 2021-2023 biennium. In this short time, we grew from an unfunded idea to a funded Washington State nonprofit with 501(c)(3) recognized status. We have spoken across the country about the creation and work of the clinic. Our clients and clinic have been featured in newspaper and online periodicals, including the Seattle Times. The clinic and its participants have been recognized with local, statewide, and national awards.

I am seeking the position of South Division District Court Judge of Snohomish County District Court driven by my passion for judicial work and the opportunity to serve my community. As a pro tem judge, I am deeply committed to upholding the core values of respect, rule of law, and efficiency. Recognizing the daunting nature of court proceedings for all participants, including defendants, victims, and attorneys, I firmly believe that everyone deserves to be treated with respect and dignity. Equally important, I prioritize the paramount principles of laws, court rules, and due process, ensuring a fair and just legal environment. Balancing the importance of these principles, I am dedicated to efficiently handling cases while ensuring that every individual has their case heard with due care. Upholding accountability for violations of the law is a vital aspect of my role, and I am proud to have upheld these values as a pro tem judge, assuring their continuation as a dedicated sitting judicial officer.

I also bring unique skills in data and technology, increasing access to justice via lived experience, and connecting community stakeholders. In my role at the law firm, I took charge of information technology resources due to my proficiency in technology from early exposure to computers. Despite limited resources and a small team, I handle tasks such as setting up computers, maintaining electronic filing systems, troubleshooting issues, and ensuring security. I provide training to colleagues on various software and technologies, while also building data systems such as a comprehensive QuickBooks accounting system and the entry data collective system for FIRST Legal Clinic. In my work with clients, I recognize the power of lived experience through programs like Parent for Parent and parent allies within the FIRST Legal Clinic to provide support for those who are struggling. This lived experience also played a crucial role in advocating for system improvements through client engagement with legislators and professionals. I also have focused on connecting community stakeholders and creating

coordinated support teams to meet clients' diverse needs. The successful establishment of the FIRST Legal Clinic involved partnerships with hospitals, organizations, and funding sources, demonstrating the power of collaboration and networking.

Snohomish County is my home. I was raised in Edmonds, Bothell, and Everett. I graduated from Meadowdale High School while attending Running Start at Edmonds Community College. I currently live in Mountlake Terrace, having recently moved from Lynnwood, with my wife and two young sons. We go to the Lynnwood pool, take the buses to get around, and go to the beaches in Edmonds and Mukilteo. Our family has connections and activities in all Snohomish County Districts. I am directly vested in the safety and improvement of our community as it grows and I care about the county's future.
